Our Terms and Conditions.

- All bookings are made on a first come first served basis.
- A 50%, non-refundable deposit is payable at the time of booking to secure your date via:
- PayPal, to email address daveanddonna@sweetcartpartyhire.co.uk
- Bank transfer to Mrs D M RICH, Sort Code: 11-07-74, Account Number: 11836860, Using your full name as the reference
- Cash, or
- Cheque, to be made payable to MRS DONNA RICH.
- Your remaining balance is payable no later than 14 days before your event or (If pre-arranged with Truly Scrumptious) cash on day of setup.
- When paying your balance, Truly Scrumptious will require a £50 breakage deposit. Assuming no damage to Truly Scrumptious property, this deposit will be returned to you within seven working days of your event.
- If booking a Sweet Table, a table suitable in size and strength will need to be provided to allow enough room for all equipment to be assembled.

We will require a minimum of 60 minutes before your event and 60 minutes following your event for both set-up and dismantling of the equipment. If booking a package with us and Buzzin Bees Soft Play, approx 90 minutes will be required.



- Cancellation charges. If you have to cancel your booking with us please be aware the following charges will apply...

Once the 50% deposit has been paid, this is non refundable

Less than 2 weeks before your event, 100% cancellation fees will apply

- Any breakage deposit already paid to Truly Scrumptious for a booking which has to be cancelled would be fully refunded.
- In the highly unlikely case that Truly Scrumptious has to cancel your booking, we will fully refund all money paid to us.

Food intolerances and nut allergies.

If you have asked for a particular food to be excluded from your Sweet Buffet we will make all attempts to make sure this is the case. Nut allergies are very common now, and Truly Scrumptious cannot guarantee that sweets purchased for consumption at your event will have no traces of nut or nut oils from production. Truly Scrumptious cannot be held responsible for issues arising as a result of your guest's selection.
